## **About the Workshop:**

The workshop focuses on development of curriculum for Ph.D. coursework as per UGC minimum standards and procedure for Award of Ph.D. Degree Regulations 2016 and University ordinance. A Ph.D. scholar shall be required to undertake course work for a minimum period of one semester which is compulsory pre-requisite for both full time and part time candidates. It shall consist of four courses namely; Research Methodology, Cognate, Research and Publication Ethics (RPE) and Specialization. The coursework will be conducted for a weightage of 12 credits.

Other courses shall be advanced level areas in the subjects concerned for enabling the students to acquire deep knowledge in the preparation for Ph.D. degree. All the candidates admitted to the Ph.D. program shall be required to complete the Ph.D. coursework prescribed by the University & respective Department during the initial/ first semester.

Research Supervisor along with Research Advisory Committee will prescribe the courses and draft faculty to teach on the prescribed courses. The faculty of the Department of Commerce will be involved in teaching of coursework, especially related to selection of title and preparation of synopsis. A candidate shall complete his/her coursework of six months through intensive classes, assignments, review of literature, short studies under the recognized Supervisor & Research Advisory Committee.

# **Objectives of the Workshop:**

- 1. To revise the syllabus as per amendment of KSOU Ph.D. ordinance 2021.
- 2. To upgrade the existing syllabus as per the latest changes in the field.
- **3.** To introduce new courses under specialization stream.
- **4.** To decide the internal assignment components based on the weightage.
- 5. To improve the quality of deliveries in the coursework of the Ph.D. program.

# **Preparations:**

- **1.** Discussed in Department council about the need of conducting 5 days' workshop for revision/upgradation of Ph.D. coursework syllabus.
- **2.** File was sent to University for seeking permission to conduct workshop. After University approval received regarding date fixing over call.
- **3.** Subject expert's availability was confirmed via calls and invitations were sent through e-mails/ WhatsApp.
- **4.** Brochures and program schedules were prepared and send to concerned
- **5.** Work was allocated by forming groups of teachers and non-teaching staff.


Prof. Jagadeesha was summed up the session as above. The session was ended with vote of thanks made by Dr. Sukanya .R.


#### **Technical Session - IX:**
