

- (1) The 146<sup>th</sup> Board of Management at its meeting held on 15.07.2017 has approved the implementation of the UGC Regulation – 2017 vide reference (1) above. The Academic Council at its meeting held on 13.09.2017 approved the decision of the Board of Management.
- (2) The University Grants Commission invited online application for the year 2018-19 vide UGC Public Notice dated 28.07.2017. Accordingly, the University uploaded online application for the year 2018-19 on 04.10.2017. The UGC by a Public Notice F.No.74-8/2017 (DEB-IV) dated 21.02.2018 cancelled all online applications uploaded during July – October 2017 and further informed to apply afresh as per the Public Notice F.No.74-8/2017(DEB-IV) dated 28.03.2018.
- (3) The University has now updated all the information till date and revised the PPRs wherever necessary. The following PPRs are placed before the Academic Council for consideration.



(4) The above PPRs were approved by the CIQA at its meeting held on 20.04.2018. The last date for submission of online application is 01.05.2018. The PPRs were prepared as per the norms prescribed under URC Regulation – 2017 (Open & Distance Learning).

(5) For the reasons stated above, the matter regarding uploading of online application for the academic session July 2018 and the PPRs are placed before the Academic Council for appropriate necessary action in the matter.

The Chairman of the Academic Council has informed the members that the University has to upload the application for the recognition of ODL Programmes for the year 2018-19. For the purpose, CIQA has revised the PPRs of various programmes i.e., UG & PG of the University.

The members have perused the PPRs placed before the meeting. The chairman stated that it may not be feasible and viable to launch B.Ed Special education, as there is no preparation. The members have also agreed on the point.

**1) Decision** : The Academic Council deliberated on PPRs approved by CIQA and approved all subjects except B.Ed., Special Education since there are no specialized faculty available for teaching the above said course and also the non-availability of study material for the course. Further, the Council decided to approve the uploading of Online application for recognition of ODL Programmes for the Academic session beginning from July 2018.

CBCS ಪದ್ಧತಿಯನ್ನು ವಿಶ್ವವಿದ್ಯಾಲಯದಲ್ಲ ಅಳವಡಿಸಿಕೊಳ್ಳುವ ಬಗ್ಗೆ.

ಕಾರ್ಯದರ್ಶಿಗಳು, ವಿಶ್ವವಿದ್ಯಾಲಯ ಧನಸಹಾಯ ಅಯೋಗ, ಸವದೇಹಲ, ಇವಲಂದ ಬಂದಿರುವ ಪತ್ರದ ಮುಖ್ಯಾಂಶಗಳು ಈ ಕೆಳಕಂಡಿವೆ.

University Grants Commission has developed Guidelines on choice Based Credit System (CBCS) and also the detailed syllabi in consultation with various stakeholders in as many as 109 undergraduate courses as a template. These syllabi of 109 courses are available on the UGC website. The template gives a broad framework of uniformity as well as inbuilt flexibility. All the Universities were requested to adopt the CBCS and also revise the curriculum.

The Chairman of the Academic Council has said that the University has received a letter from the UGC related to implementation of the CBCS. The chair also stated that CBCS needs to be included as part of the curriculum in the University. Further he highlighted that CBCS is implemented in conventional university effectively but may not be in ODL System. In order to implement CBCS effectively the University needs to constitute a committee which will work out the methodology .

The detailed discussion took place on the said subject along with revision or upgradation of curriculum including evaluation of the assignment.

**2) Decision** : The Academic Council approved the adaption of CBCS system in principle. Also decided to constitute a Committee to look into modalities, framing of Ordinances to change the present system to CBCS and to revise the curriculum under semester scheme.




**45:3 Other matters:**

**Decision:** The Academic Council resolved to form Committees under the Chairmanship of Registrar (Evaluation) to look into the issue of assignment evaluation and to formulate guidelines for the same and a Committee under the Chairmanship of Dean (Study Centres) to look into duties and responsibilities of co-ordinators and other staff of Study Centres.
