ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to Karnataka State Open University, Manasagangotri, Mysore-570006, Karnataka for B.Ed through Distance Education of two years duration from the academic session 2000-2001 with an annual intake of 500 students (including Nodal Centre and Study centres), subject to fulfilling the following conditions:

- 1. Existing SIM should be further improved.
- University should take up production of A/V programmes with free lance producers and outside production facilities.
- 3. Faculty and other staff including teacher educators at study centres be strengthened.
- 4. Among the study centres mentioned, one college viz., Tagore College of Education, Raichur is not a recognised institution and should not be selected as study centre. Only recognised institutions should be selected as study centres.
- All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- 6. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
- 7. The admission to the approved dourse shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the University / State Government.
- Tuition fee and other fees will be charged from the students as per the norms of the University / State Government till such time NCTE regulations in respect of fee structure come into force.
 - Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the University / examining body.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
